## Roles And Responsibility (General)

- **Joint Evaluation:** Both entities will collaborate in evaluating the course content and delivery to ensure its effectiveness.
- **Training Organization:** They will jointly organize training sessions and supportive activities within the framework of the MOU.
- **Compliance Assurance:** The performance and obligations of each party will be conducted in a manner that respects third-party rights and pre-existing agreements, to avoid causing any issues.
- **Program Promotion:** The parties will actively advertise and propagate the programs through their respective platforms, maximizing outreach and engagement.

## Financial Arrangement

- Training fees will be determined jointly by both the Institute and Vibrantick for all collaborative programs.
- Neither 'The Institution' nor 'The Company' will be responsible for the financial commitments of the other.

## Duration And Termination of Agreement

- 'The Company' must inform 'The Institution' Two months in advance if they wish to terminate the contract and fulfil all ongoing obligations.
- 'The Company' is responsible for the success of longer-duration batches, if any.


